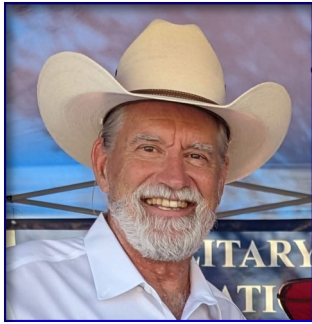

The Work Ahead: As a community of shared and diverse military experiences, we need to band together on behalf of veterans, from those exposed to Agent Orange during the Vietnam War, to air crew exposed to toxic substances, to younger veterans sickened by burn pits in Iraq and Afghanistan.

Ending the Wait for Toxic-Exposed Veterans, is a report that outlines more than a century of such military based exposure. Unfortunately, the Veterans Administration often delays adequate responses to these incidents. On average, veterans must live through 34.1 years, from exposure to full benefit access. The report also provides a series of recommendations to create a faster, fairer process for all toxic-exposed veterans – past, present, and future. Consider educating yourself on this topic (and reacting appropriately) at the above link.

ACES Act: Under the Aviation Cancer Examination Study (ACES) Act, signed into law Aug. 14, the National Academies of Science, Engineering, and Medicine (NASEM) will conduct a study for the VA identifying potential unhealthy exposures faced by aircrews and how those exposures could associate with higher cancer rates, more cancer-related deaths, and rates of specific cancers such as brain, lung, pancreatic, and thyroid, among others. The ACES Act was one of MOAA's top legislative priorities. Because of grassroots advocacy, it is now the law. Your voice is heard in Congress. [BACKGROUND: DoD Report Shows Higher Cancer Rates for Aviators, Ground Crew Members]

Funding the Government: The long and short of the end of the fiscal year and the Oct. 1 government funding deadline is a potential for a short-term continuing resolution (CR) to extend funding into November (Continuing Resolution text). However, while a CR is far less disruptive than a shutdown Congress has missed the deadline for passing all appropriations bills for more than a quarter-century, and while stopgap measures may keep the lights on, they delay readiness investments, quality-of-life improvements, and health care reforms while wasting billions of taxpayer dollars.

A shutdown halts many federal operations outright. Servicemembers must report for duty during a shutdown, but their paychecks may stop unless separate legislation is passed to authorize compensation. Coast Guard members, uniformed personnel in the U.S. Public Health Service and NOAA may go w/o pay during a shutdown. PCS moves and training schedules may be delayed or canceled. Veterans may see slower processing of disability claims and other VA benefits, while families could lose access to child care, commissaries, and other support services.

The House passed version of the NDAA provides for several high SMVF (Service Member, Veteran, and Families) priority items. More information is available in the weekly MOAA Newsletter. Please consider contacting our Senator and encouraging them to move forward on funding the Federal government and enacting an NDAA.

Please continue using the Legislative Action Center and supporting MOAA's priorities. And spread the word—friends, neighbors, and non-members can also use the LAC to support veteran legislation and protect earned benefits. Every voice matters, and every action strengthens our mission.

Per Coronado MOAA Bylaws, our membership shall be composed of (a) Men and women who are or have been officers — that is, commissioned or warrant officers of the regular, reserve or National Guard of the United States in one of the eight US uniformed services of the Army, Navy, Air Force, Marine Corps, Coast Guard, National Oceanic and Atmospheric Administration, Public Health Service and Space Command. (b) Widows and widowers of deceased members or of any deceased individual who would, if living, be eligible for membership. (c) Individuals elected as Honorary Members as set forth in Section 2(e) of this Article. There shall be no discrimination in membership or participation in the affairs of the Association by reason of race, creed, color, national origin, sex, handicap, or age.
